







6. **The bids will be opened in the presence of bidders representatives who choose to attend at 31-08-2022 15:00 at the office of Godaita Municipality, Sarlahi. Bids must be valid for period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of bid security in pdf format in case of e-bid, amounting to a minimum as specified in table of following works which shall be valid for 30 days beyond the validity period of bid.**

If the bidder and parties constituting the bidder has participated in bidding process of many public entities and during that period the maximum number of contracts as specified saturates due to issuance of letter of acceptance by a particular public entity, the bidder shall inform in written to all other concerned public entities, where the bidder have participated in bidding process, within three days of issuance of last letter of acceptance that saturates the maximum number of contract as specified.
