- 7. The bids will be opened in the presence of bidders representatives who choose to attend at 20-11-2023 15:00 at the office of Godaita Municipality, Sarlahi. Bids must be valid for period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of bid security in pdf format in case of e-bid, amounting to a minimum of Nrs. 4,00,000.00 which shall be valid for 30 days beyond the validity period of bid.
